CONFERENCE OVERVIEW

Program Description

The conference will provide an evidence-based update on management of all types of Lymphedema, and promote interprofessional treatment of lymphedema in Saskatchewan that is consistent and based on best-practice guidelines. The format will include plenary sessions, interactive small group workshops, and interprofessional case discussions.

Who Should Attend

The target audience for the conference is: Physical Therapists, Physicians, Occupational Therapists, Nurses, Nurse Practitioners, Massage Therapists, Kinesiologists, Podiatrists, students in these disciplines, other interested health professionals, policy makers and program planners.

What You Will Learn

After attendance at this conference participants will be able to:

- *Describe and implement the best practice guidelines for treatment of all types of lymphedema, regardless of cause.*
- *Facilitate compression management strategies across Saskatchewan, consistent with best evidence.*
- *Outline treatment-planning principles for lymphedema management that are consistent across the province to mitigate the consequences of lymphedema.*
- *Facilitate lymphedema management program planning to ensure maximum benefit for patients with lymphedema in Saskatchewan, including development of a provincial provider list.*

KEYNOTE SPEAKERS

Andrea Cheville, MD, MSCE is an Associate Professor of Physical Medicine and Rehabilitation at the Mayo Clinic in Rochester, MN. After attending Harvard Medical School, Dr. Cheville pursued her interest in Cancer Rehabilitation through residency at the Kessler Rehabilitation Institutes and fellowship at Memorial Sloan Kettering Cancer Center. Dr. Cheville's training emphasized lymphedema management, symptom control, and functional preservation. In 1999 Dr. Cheville accepted the University of Pennsylvania Health System's invitation to develop a Cancer Rehabilitation and Lymphedema Program. During the seven years of her directorship, the program expanded dramatically in clinical and research prominence to become one of the most recognized in the country. Dr. Cheville moved to the Mayo Clinic in 2006 to pursue her research in breast cancer-related lymphedema which focuses on protecting the lymphatic system during primary breast cancer treatment and enhancing its innate capacity to heal. Dr. Cheville has written and lectured extensively on these topics, as well as lymphedema staging and clinical management. Her research is currently funded through the Department of Defense and National Institutes of Health.

Janet McFarland, BScPT, CDT graduated with a BSc PT from the University of Toronto in 1979. She completed her initial CDT training in 1990 in Austria. Currently she co-directs two physiotherapy clinics

with Sharon Langfield, Toronto Lymphocare Centre and Cookstown Centre for Wellness, and teaches Integrated Lymph Drainage and CDT in Toronto, Canada. Jan McFarland has a passion for focusing on the whole person within health care models whether presenting at conferences, teaching students or working with clients. Integrated Lymph Drainage – their Canadian based training, integrates new science from various disciplines, within a comprehensive Combined Decongestive Therapy (CDT) framework. Jan is an Advisory Board Member with the Canadian Lymphedema Framework.

Dorit Tidhar, BPT, is a physiotherapist who was trained in lymphedema therapy by Prof. Judith Casley-Smith in 1999 and was certified by her as a teacher in Self Management and Exercise for Lymphedema in 2003. She designed the program Aqua Lymphatic Therapy – Tidhar Method to help people who suffer from lymphedema maintain and improve the results of conventional treatment and conducted a randomized controlled trial as part of her Master's degree in Tel Aviv university in Israel, to examine this method. She has published 5 articles in scientific journals. Dorit is now working at the McGill University Health Centre's Lymphedema Clinic in Montreal as a clinician and an instructor and is coordinating the educational program for lymphedema therapists, physiotherapists and nurses in various subjects related to lymphedema.

INVITED SPEAKERS

Asim Amjad, MD, is a Radiation Oncologist and an Assistant Professor for the College of Medicine, University of Saskatchewan. He trained in Ireland and the United Kingdom. He has been working with the Saskatchewan Cancer Agency since 2008 and has a special interest in breast, prostate and cervix cancer. He is currently the Provincial Lead Oncologist for breast cancer.

Simon Davies, BSc DPodM started his career in Podiatric Medicine in 1986, attending Huddersfield University in Northern England and Edinburgh University in Scotland. He has worked for British and Canadian Health Authorities/Regions/ Hospitals in Community and Acute Care, and specialized in Vascular and High Risk Podiatry, Pediatric Podiatry, Rheumatology and Biomechanics for the lower limb. He has been in private practice for 13 years, the last 7 of which have been in Saskatchewan as a Registered Podiatrist with the Saskatchewan College of Podiatrists.

Pam Fichtner, RMT/CDT was trained in Manual Lymph Drainage with the Dr. Vodder School and has her first two levels of Lymphatic Drainage with the Chikly Institute. She has been practising as a massage therapist since 1998. She supports people holistically and has worked extensively with breast cancer patients. She teaches Breast Massage and complementary health workshops throughout Canada. She has her BA in Sociology and is continually taking training in other modalities. She is involved in a variety of research projects at the University of Saskatchewan including the ethnodrama lymphedema project and creative practices for people with cancer.

Tracy Gardikiotis, BScPT, CLT-UE, CCES is a physical therapist who graduated from the University of Saskatchewan in 1998 with a BScPT. She has worked in the areas of inpatient orthopedics and medicine, and outpatient orthopedics and lymphedema management at the Plains and Pasqua Hospitals in Regina, SK. Tracy has been the senior therapist on the lymphedema service at Pasqua Hospital in Regina since 2005 where she specializes in upper extremity/breast cancer related lymphedema. She has completed extensive post graduate training in breast cancer rehabilitation and lymphedema management including: certified fitter for JOBST, JUZO, VALCO and PENNISULA MEDICAL products, Certified Lymphedema Therapist (CDT/MLD) by Klose Training and Consulting in 2010, Certified Cancer Exercise Specialist by The University of Northern Colorado Rocky Mountain Cancer Institute in 2010. She is a committee member of the Saskatchewan Lymphovenous Learning Association (SLLA) and The Saskatchewan Breast Cancer Network (SBCN)

Barb Lauterbach, RN is a nurse of 32 years with a varied background in acute care, most recently in a management position on a Medical-Palliative unit. She has been off work for medical reasons since late 2009. In 2010 she was diagnosed with Primary Lymphedema.

Her areas of interest include breast cancer survivorship, caring labour, work organization, and research methods. With Dr. Roanne Thomas, Quinlan leads a CIHR-funded research project on arm morbidity among breast cancer survivors.

1. **Lymphedema and the Feet** S. Davies
In the general Population the feet are one of the most relied upon parts of the body, unfortunately they are also one of the most neglected. Conditions that affect the feet such as Lymphedema carry increased risks that patients and care givers need to be aware of. Proper foot care and footwear are essential, as is education on caring for the feet.
Learning objectives:
 - a. Understanding the foot: Introduction of basic foot anatomy, increase foot awareness through interesting facts.
 - b. Foot Risks in Lymphedema: Covering the most pertinent effects of Lymphedema in the feet and the importance of prevention.
 - c. Foot Care: How to care for the feet routinely, Do's and Dont's, Footwear.

2. **Mixed Etiology Edema –**A. Cheville
This session will provide an overview of local and systemic factors that can aggravate lymphedema. Since many of these may be remediable, screening for such factors should be an integral part of lymphedema clinical evaluations.

 - a. Describe physical examination maneuvers and serologies to screen for solid organ dysfunction as a source of edema
 - b. List medications that can cause swelling

Managing lymphedema requires solutions that involve more than purely physical strategies and management techniques. This workshop will explore various strategies for sharing essential lymphedema information in an empowering framework. We will explore how to educate our clients in ways that support curiosity, creativity and personal wisdom in order to manage their lymphedema while living fully.

Lymphedema can have devastating effects on breast cancer survivors' work, leisure and intimate relationships. "We've been mutilated. Lymphedema is the cruel joke at the end of all this treatment. It's permanent and a constant reminder that, yes we've had breast cancer."

Friday, April 20, 2012, cont'd

As these words, spoken by participants of our CIHR-funded survivorship research, indicate the physical impacts of breast cancer surgery, such as lymphedema, also carry the freight of psychological wounds. This session describes the findings from our national research project that uses theatrical performances concerning the psychosocial effects of lymphedema to reach audiences of providers and survivors in 4 Canadian cities. Suggested approaches to deal with these psychosocial issues will be offered by one of the research team's clinicians, Pam Fichtner.

Description:

This workshop will discuss in depth ways to achieve compression gradient; how to apply a safe compression system and how to deal with specific problems (swelling of the hand, swelling of fingers, pain in the wrist, redness and tightness over the elbow etc.); how much reduction to expect; when to measure for a garment and how to evaluate whether the garment is a good fit. The practical session will give tools for applying a safe compression system and dealing with different situations according to objective measurements.

Learning Objectives:

The therapists will

- Learn of how to use the Laplace Law in the application of a safe compression system
- Understand how to change the bandaging according to objective feedback
- Practice one set of bandaging (leg& arm) and be able to determine the amount of compression that is applied.
